# **TOTAL MLS VOLUME FOR THE MONTH OF JANUARY 2011**

Net Closed Volume for the month of January 2011 was \$48,822,120. There were 1583 listings processed, 272 closed sales. Compared to last month, Net Closed Volume is down \$42,439.648. Listings are up 735, sales are down 218. Compared to last year, Net Closed Volume is down \$364,932. Listings are down 156, sales are down 4. Mandatory sales volume was \$35,364,873. Non-Mandatory sales volume was \$13,457,247. Pending sales (figured on list price) were \$55,334,783. There were 314 pending sales processed.
