

# TOTAL MLS VOLUME FOR THE MONTH OF MAY, 2021

Net Closed Volume for the month of May, 2021 was \$406,017,644. There were 1,541 listings processed, 1,055 closed sales. Compared to last month, Net Closed Volume is up \$53,294,519. Listings are up 66, sales are up 79. Compared to last year, Net Closed Volume is up \$189,080,171. Listings are up 51, sales are up 204. Mandatory sales volume was \$387,329,328. Non-Mandatory sales volume was \$18,688,316. Pending sales (figured on list price) were \$503,838,284. There were 1,261 pending sales processed.
