TOTAL MLS VOLUME FOR THE MONTH OF OCTOBER, 2021

Net Closed Volume for the month of October, 2021 was \$433,633,450. There were 1,338 listings processed, 1,092 closed sales. Compared to last month, Net Closed Volume is down \$31,298,392. Listings are down 350, sales are down 63. Compared to last year, Net Closed Volume is up \$26,744,421. Listings are down 94, sales are down 122. Mandatory sales volume was \$403,768,354. Non-Mandatory sales volume was \$29,865,096. Pending sales (figured on list price) were \$507,794,093. There were 1,221 pending sales processed.
